Trial 1 and Trial 2 will run concurrently – lunch at judge's discretion.

Due to multiple events, we will NOT be required to run in arm band number. Please make stewards aware of potential ring conflicts. Judges **ARE NOT** required to wait for exhibitors.

DIRECTIONS TO EVENT SITE:

From North or South: Follow I-39 to US-10 East to Western Way, turn left on Western Way to Fairground Road. Turn right on Fairground Road. The fairgrounds are on the Right.

From East/West: Follow US-10 East of Stevens Point to Western Way, turn left on Western Way to Fairground Road. Turn right on Fairground Road. The fairgrounds are on the Right.

REFUNDS: Requests received prior to the closing date will be honored, subject to a \$5.00 administrative fee.

Entry fees will not be refunded in the event a dog is absent, disqualified, excused by the judge or veterinarian, barred from Competition by action of the event committee or UKC, or pulled after closing due to injury or any other medical condition. Every effort will be made to find all duplicate entries before processing. If a duplicate entry is processed, however, no refund will be made.

No entry fees will be refunded if the event cannot open or be completed by reason of riots, civil disturbance, fire, an act of GOD, public emergency, or any other cause beyond the control of the event committee.

Females who come into season after the closing date will have entry fees refunded subject to a \$5.00 administrative fee, provided a veterinarian's certificate verifying female came into season after closing date for entries. The certificate may be mailed, provided the postmark is no later than the date prior to the date of the trial, or delivered by hand to the event secretary a half hour before the published start time of the trial.

Returned checks do not constitute a valid entry fee. These entries and any/all results will be pulled. The club will add \$35 for each returned check.

The host club, their agents, members etc., assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers or any of their dogs or property.

SUBSTITUTIONS:

Substitutions will be allowed. Day of show fees will apply to any substitutions made after the closing deadline, except for females entered in Junior showmanship who come into season.

CORRECTIONS: Owners are responsible for the accuracy of information in the entry forms, regardless of who may make such errors. If an exhibitor is not called for their correct class or is called for an incorrect class, it is their responsibility to ask the steward to stop the show and check with the show secretary to correct the error. Owners and exhibitors are responsible for correcting any errors in their entry.

CLASS CHANGES & MOVE UP:

PERFORMANCE: ALLOWED BETWEEN DAYS ONLY (not between trials)

CONFORMATION: ALLOWED BETWEEN SHOWS

Exhibitors are responsible for getting the completed UKC class change paperwork to the secretary. Incomplete forms will not be processed and will be returned. Forms MUST be processed prior to allowance of a move-up or change.
